### PROCEEDINGS IN BRIEF

- Convene an urgent, structured, Community meeting and forum to consider the advice of our residents and to collate the concerns and opportunities that our own community see with the EIE as currently proposed;
- 3. If, as a result of the public forum, alterations are made to the draft submission, Council reconvene to endorse the final and formal submission as soon as practicable;
- Expresses deep concern about the State Government's irresponsible approach to planning for the future of the built and natural environment in NSW;
- 5. Rejects the proposed changes to planning controls and demands that they be withdrawn with genuine consultation to be undertaken with councils and their communities, as intended by the *National Housing Accord 2022*;
- 6. Explores all options to oppose the changes and stop them being implemented;
- 7. Rejects the proposed changes because they will have a profound and detrimental effect on heritage, the conservation areas, sustainability and the need to meet targets set by the *Greening Sydney Strategy* as the proposed reforms will leave inadequate space for trees and gardens, values held deeply by the Hunter's Hill Community;
- 8. Continue to actively inform the community, and request Northern Sydney Regional Organisation of Councils and Local Government NSW lobby against the proposed changes to planning controls;
- 9. Arrange for banners in key locations to alert residents to the proposed changes, with expenditure to come from unrestricted funds;
- 10. Continue to actively campaign against the proposed changes, collaborating with the community, councils and other stakeholders; That Council continue to work with the Northern Sydney Regional Organisation of Councils to support collective regional action, to ensure the reforms achieve desired aims and endorse the key issues expressed from the Extraordinary NSROC meeting on 15 February 2024, including the lack of clarity regarding the detail of the reforms, the move away from Council's local strategic planning framework, and not adopt a one-size-fits-all approach to the expected impact on our residential streets and neighbourhoods including our heritage conservation areas; and
